## YOUR CHILD'S MENINGITIS ACWY AND TETANUS/DIPHTHERIA/POLIO VACCINATIONS ARE NOW DUE

Kernow Health is delivering the school-age immunisation programme in Cornwall on behalf of NHS England. We will be immunising **year 9 girls and boys** against Tetanus/Diphtheria/Polio and Meningitis ACWY during this academic year, 2021/22.

## **Meningitis ACWY**

This vaccine protects against Meningitis (inflammation of the brain) and Septicaemia (blood poisoning) caused by Meningococcal groups A, C, W and Y.

The vaccine is being offered in response to a rapid increase in cases of Meningococcal disease group W, an aggressive strain.

## Tetanus/Diphtheria/Polio

Your child will also receive an immunisation against Tetanus, Diphtheria and Polio. The teenage booster, also known as 3-in-1 or the Td/IPV vaccine, is given as a single injection into the upper arm to boost your child's protection against the three separate diseases.

The teenage booster is available **for all young people in school year 9** and is generally given at the same time as the Meningitis ACWY vaccine.

These vaccines will normally complete your child's immunisation in accordance with the NHS England schedule.

Our visit to your child's school is **on Monday 27June 2022** and you will need to submit your form **by midday on Wednesday 22 June 2022** to ensure your child receives their vaccination. As well as visits to the school we will be running catch-up clinics during the course of the year to give every opportunity for your child to be immunised. As in previous years you must **opt-in** to the programme. If a consent form is not submitted your child might not be vaccinated.

 Please note: Your child can self-consent to treatment if they are considered competent to do so by one of our nurses; this is known as Gillick competency.
